The Government of Bangladesh is implementing "Support to Development of Kaliakoir Hi-Tech Park (and Other Hi-Tech Park) Project" under the Private Sector

Development Support Project (PSDSP) financed by IDA and DFID. Kaliakoir Hi-Tech Park (KHTP), now known as Bangabandhu Hi-Tech City (BHTC), is the first ever Hi-Tech Park in Bangladesh which is located at Kaliakoirupazilla in Gazipur district covering 232 acres of land. With firm objective of creating employment opportunities through the establishment of knowledge-based industries in general, and IT/ITES and advanced Hi-Tech industries, this park will be a milestone for world class business environment/investment zone especially for the foreign investors where they can easily utilize the vast potential of young educated and technically skilled work force. In addition to KHTP, Bangladesh Hi-Tech Park Authority (BHTPA) is responsible for the establishment and expansion along with management, operation and



Impact Assessment of electronic Government Procurement (e-GP) and Other Selected Interventions (Central Procurement Technical Unit, IMED, Ministry of Planning)

The Central Procurement Technical Unit (CPTU) is responsible for setting procurement policies, and for overseeing their implementation across Government agencies. As a key innovation, CPTU has since 2012 supervised the role-out of Bangladesh's electronic Government Procurement System (e-GP). Bangladesh's e-GP System presently digitize the whole contracting method, from the advertisement to concluding

development of Hi-Tech Parks like Jessore Software Technology (IT) Park, Sylhet Hi-Tech Park, Mohakhali IT Village, Janata Tower Software Technology Park and 12 other IT Parks. As a part of this development process, Monitoring and Evaluation Sector-7, IMED, Ministry of Planning, signed an agreement with MIDAS on February 8, 2018 for conducting Indepth Monitoring of the project.

As per the agreement,MIDAS prepared an inception report about the indepth study methodology and implementation and submitted to concerned IMED authorities for approval. Through the Meeting of Steering Committee and then the Technical committee, the inception report was approved. Accordingly, MIDAS finalized the data collection tools and provided training to the field enumerators. As part of the study, field survey along with conducting Focus Group Discussion and Key Informants Interview, etc., are going on. After collecting necessary data and information, these will be analyzed to prepare in-depth monitoring report for submission to IMED.

payment. It assembles and publishes vast amount of comprehensive records placing it among the progressive procurement systems according to the emerging global standard: Open contracting Data Standard. So far, the e-GP system has primarily been rolled out in four major agencies-Local Government Engineering Department (LGED), Roads and Highways Department (RHD), Bangladesh Water Development Board (BWDB) and Bangladesh Rural Electrification Board (BREB).

In order to assess the e-GP System of Bangladesh, CPTU assigned MIDAS for aconsulting services for collection of tender related data from the

three Government agencies-RHD, LGED and BWDB. First time in Bangladesh, the data is being collected digitally under this assignment which is jointly financed by the World Bank and Government of Bangladesh. With the support of concerned three government agencies and CPTU,MIDAS conducted Tender Listing Survey (TLS) in the first phase of the assignment, where basic information of all manual tenders executed during5-year period (2011-12 to 2015-16)were collected from RHD, LGED and BWDB in all the 64 districts of Bangladesh. After conclusion of TLS, a detailed sampling survey of manual tenders in all the 64 districts is going on digitally using Tabs in the second phase. The digital survey is expected to be completed in May 2018.

Baseline Survey for Global Multi-Tier Measurement for Access to Energy

MIDAS was assigned by Power Cell to conduct a "Baseline Survey for Global Multi-Tier Measurement for Access to energy" for Rural Electrification and Renewable Energy Development II (RERED II) Project funded by the World Bank. For the first time in Bangladesh a baseline survey was carried out on access to electricity and better cooking using the Global Tracking Framework (GTF). 6 sets of elaborate survey tools provided by World Bank were used for collecting data through Tabs from the field. These tools were used in other countries of similar Baseline survey introduced by World Bank. However, these survey tools were further adjusted and improved considering Bangladesh perspective. Six Survey teams of MIDAS, each team composed of 6 enumerators, a supervisor, and a quality control person, carried out digital survey in 375 Enumeration Areas (Wards of City Corporations and Villages) of twelve selected districts, namely, Dhaka, Chittagong, Comilla, Sylhet, Mymensingh, Rajshahi, Bogra, Rangpur, Nilphamari, Khulna, Jessore and Barisal. There were six groups of respondents of the survey comprising of i) household ii) Place of Worship, iii) Community, iv) Health Facility, v) Education Institution and vi) Government Office / NGO. Collected data was uploaded in the central cloud server through internet from the field. During the January-March period, several post survey activities, such as, data cleaning, data editing, data processing and statistical analysis werecarried out. After completion of the detailed analysis of the survey data, a comprehensive report will be prepared for submission to Power Cell.

Monitoring, Evaluation, Design and Supervision of ASSSRB Project









MIDAS is executing a consultancy services in the field of Monitoring, Evaluation, Design and Supervision of Agricultural Support for Smallholders in South-Western Region of Bangladesh (ASSSRB) Project. This is a project of the Department of Agriculture Extension(DAE) under the Ministry of Agriculture of the Government of Bangladesh. The purpose of the project is to improve the livelihood of landless, marginal and small farmers through integrated and sustainable production. The project is being implemented by DAE and LGED in 58 Upazillas of 9 Districts of South-Western region- Gopalganj, Madripur, Barisal, Patuakhali, Jhalakathi, Barguna, Bhola, Pirojpur and Bagerhat. Involvement of MIDAS with ASSSRB Project commenced in January 2016 and will run on till June 2018.
