## Monitoring Structural and Non-Structural Interventions of UNDP's CDMP (Phase II)

For vulnerable communities in Bangladesh, the Comprehensive Disaster Management Programme (CDMP) -Phase II is one of the main mediums for institutional reform, capacity building, and reducing impact of disaster and climate risks. Under the programme, small to medium scale structural and non-structural interventions at the local level were financed. CDMP will be reaching out with new risk reduction interventions/schemes in 500 unions of 40 districts by the end of the project in 2015. To ensure national level project intervention quality, CDMP has engaged MIDAS as a third party independent monitoring body. MIDAS monitoring whether the project schemes are up to the acceptable standard in terms of results, process, effectiveness, quality, and accountability of the Local Disaster Risk Reduction Fund (LDRRF) -supported interventions.

In the First Phase of the assignment, during August-December 2013, MIDAS Monitoring Team physically verified 832 interventions that were funded by CDMP II of UNDP and implemented by the Project Implementation Committee (PIC), Union Parishad. The interventions are situated in 196 Unions of 73 Upazilas of 33 Districts of Bangladesh. MIDAS Monitoring Team developed and used seven different monitoring tools to collect relevant information from the field for this assignment.

MIDAS also conducted 46 Focus Group Discussions (FGDs) in 302 Unions of 33 Districts with key stakeholders and knowledgeable person with familiarity with the CDMP interventions of their respective localities. individual Moreover, 756 interviews experienced persons of the intervention areas were documented. Based on the findings, MIDAS Study Team prepared and submitted the Independent Monitoring Report-1 Comprehensive Disaster Management Programme II (CDMP II) of UNDP. The findings will facilitate CDMP II, UNDP in designing an action plan for strengthening the current disaster risk reduction program and future advocacy possibilities.

#### **Training**

## Mediscan Limited (Hospital & Diagnostic Complex)

Kapteijns arranged for a modern Digital X-ray Machine (capacity 1000mA), a generous donation by Philips Healthcare, Germany. The present market price of 1000mA digital X-ray machine is BDT 1 crore 80 lac (estimated USD 231,000).

Mr. M. Van Overeem, PUM expert on engineering, came along to set-up the digital X-Ray machine. He also trained the Operators to run the machine which is capable of instantly producing high quality images. If monetized, this in-kind contribution of providing a state-of-the-art machine and training of machine operators is fairly substantial as well.

MIDAS is the resident representative of PUM-Netherlands since 1996, providing services of Dutch Volunteer Advisors to requesting local organizations. The experts do not charge fees for their services. The recipient organization has to bear the cost of expert's local expenses only.
